







# The Gestal Group, controlled by FCDE, welcomes BNP Paribas Développement, Bpifrance, and Sodero into its shareholding structure to support its new phase of development

// Leading player in industrial services, the Gestal Group has more than doubled its revenue since FCDE became its majority shareholder in 2019.

// After a period marked by a strong organic growth driven by its management team led by Olivier Aldrin, this operation opens a new chapter for Gestal, aiming at accelerating its growth path through external growth strategy.

Gestal is a major player in industrial services, serving leading industrial clients. Since FCDE became the majority shareholder of the group in 2019, its revenue has grown from €53 million to €112 million in 2023, primarily through organic growth. During this period, Gestal was able to rely on the strong order books of its historic clients operating in promising sectors such as aerospace and shipbuilding, while capitalizing on its recognized expertise to expand into new areas such as defense and renewable energies. This growth path was further accelerated by four acquisitions (Roma2S, TIS, RCT Industrie, and Setca), which allowed Gestal to expand its geographical reach to the south-western quarter of France (Bordeaux, Poitiers, and Toulouse) and internationally (Romania), while strengthening its position in high-growth sectors such as nuclear, pharmaceutical, and green chemistry. Additionally, Gestal has established a presence in Canada to support its clients, marking the first step in its transatlantic development.

The group's continued growth now relies on executing an ambitious external growth strategy, aiming at expanding its geographical footprint in France and internationally and acquiring complementary expertise and centers of excellence in key industrial verticals.

The acquisition by BNP Paribas Développement, Bpifrance, and Sodero of an equity stake in Gestal, along with the support of the group's historical banking partners, which notably enabled the securing of a significant financing facility dedicated to external growth operations, provides Gestal with strengthened human and financial resources to reach new development milestones.

**Olivier Aldrin, President of Gestal,** stated: "I warmly welcome the arrival of renowned investors such as BNP Paribas Développement, Bpifrance and Sodero as shareholders of the group, and I am delighted by FCDE's renewed confidence. The support of these shareholders will allow us to pursue an ambitious growth trajectory and significantly accelerate our external growth strategy, enabling us to expand our geographical footprint and support our clients across their various sites."
