// Backed by FCDE, the majority shareholder, alongside BNP Paribas Développement, Bpifrance, and Sodero Gestion, Gestal continues its national growth strategy and diversification through the acquisition of SMS, marking the group's fifth external growth operation since FCDE's investment

The Gestal Group has acquired 100% of the shares of SMS, a company based in Toulouse and Albi (Occitanie), from its existing shareholders, Yves and Sabine Clergue. This acquisition is part of Gestal's ambitious strategy for national development and sectoral diversification, supported by FCDE. It enables the group to strengthen its industrial maintenance division and expand its footprint in the Occitanie region.

Founded in 2011, SMS specializes in industrial maintenance and metallurgy (steel and stainless steel), serving a wide range of sectors including specialty chemicals, glass, recycling and other process industries. With a team of around 40 employees, SMS delivers comprehensive electromechanical maintenance services as well as new construction projects across the Occitanie region.

With strong expertise and a customer base that complements those of TIS (Castres) – a Gestal subsidiary specializing in high-performance industrial piping – SMS strengthens the group's footprint in the Toulouse industrial region. Gestal now employs 60 people across the region. This integration creates significant commercial synergies between the two entities, enabling Gestal to support its clients in more ambitious industrial maintenance programs and to further consolidate its position as a leading regional player.

Olivier Aldrin, CEO of Gestal, stated: "This external growth operation strengthens our presence in Occitanie and enables us to better support our clients in addressing their industrial challenges, with a comprehensive range of expertise and capabilities."
